To be valid, nominations must comply with the following criteria:

- a) At least 75% of the Parents' Association Committee must support the nomination. Please seek consent from the committee members approving, to share their email and/or telephone number with NPC and we will follow up with them to verify approval, to ensure fair procedure.
- b) The nomination must be accompanied by the required evidence as stated in the attached *Evidence of Support Form*.
- c) The nomination must be returned to NPC Administrative Officer, Michelle Davern, not later than the 5th of June 2024 please see details below.
- d) Each of the two members nominated, one man and one woman, shall be a parent of a child who has not reached 18 years of age and is registered as a student in a centre for education or recognised school. The nominee must have no conflict of interest please see important note at end of form *.
- e) The person nominated must have consented to his or her appointment as a nominee in the event that he or she is elected.
- f) The person nominated shall provide a short biography incorporating a personal statement outlining their capacity and vision for the role (not exceeding 300 words). This will be sent to all Parents' Associations in the ETB area in the event of a ballot, a head-shot photograph can be included if desired.
- g) The nomination must be made on this form
- h) Where nominations are returned by email or post, the following must be included:
 - Nomination form (this form), which includes consent from the nominee
 - A short biography from the nominee on the Biography Form (not exceeding 300 words)

It should also be noted that the Act provides that a person must not be a member of more than one education and training board at any one time.

Also, a person should not be a board member if they are a "relative" to any other board member of that ETB - relative has the meaning ascribed to it under the definitions of the Ethics in Public Office Act 1995, (i.e. brother, sister, parent, spouse/civil partner or a child of the person or of the spouse/civil partner);

Board members should not be a "relative" as defined above to an officer who is ineligible to be a member of that ETB as defined in SI 141 of 2019 (i.e. Chief Executive, Directors of Organisation Support and Development, Schools and Further Education and Training, Adult Education, Personnel and Finance Officers, School Principal, Training Centre Manager and Assistant Manager, Manager of a centre for education, and all other grades of staff, the duties of which are wholly or mainly of an administrative, executive or clerical nature and the maximum remuneration for which exceeds the maximum remuneration for the grade of Clerical Officer);
